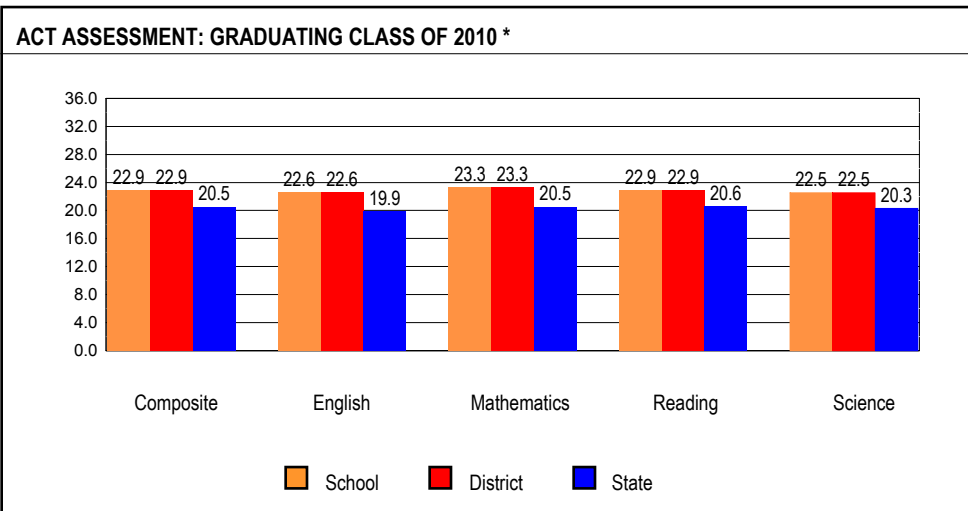

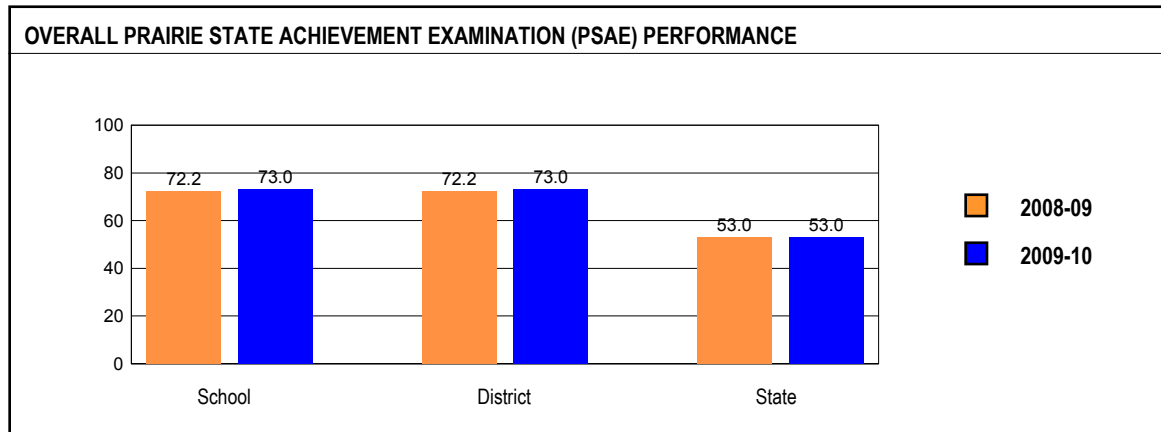
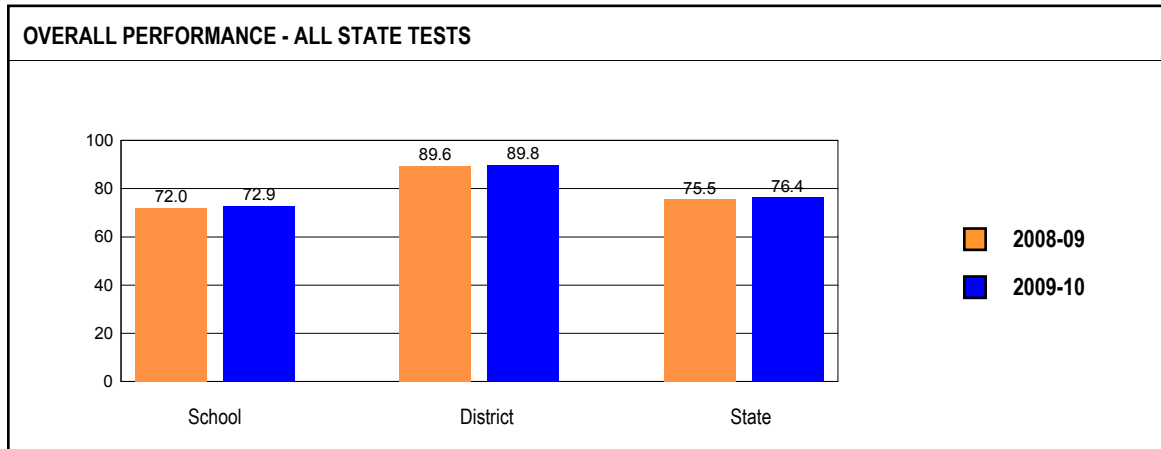

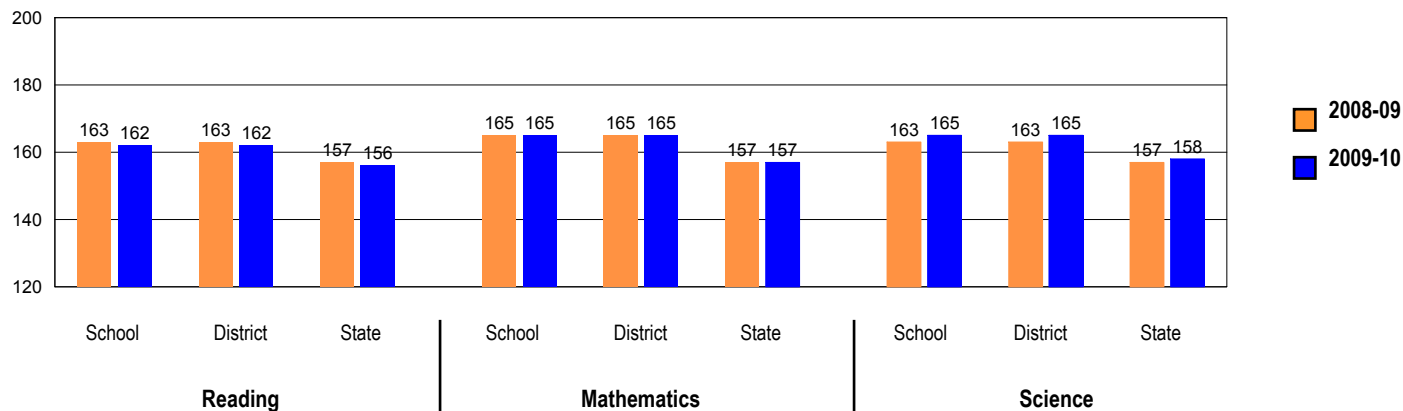
OVERALL STUDENT PERFORMANCE

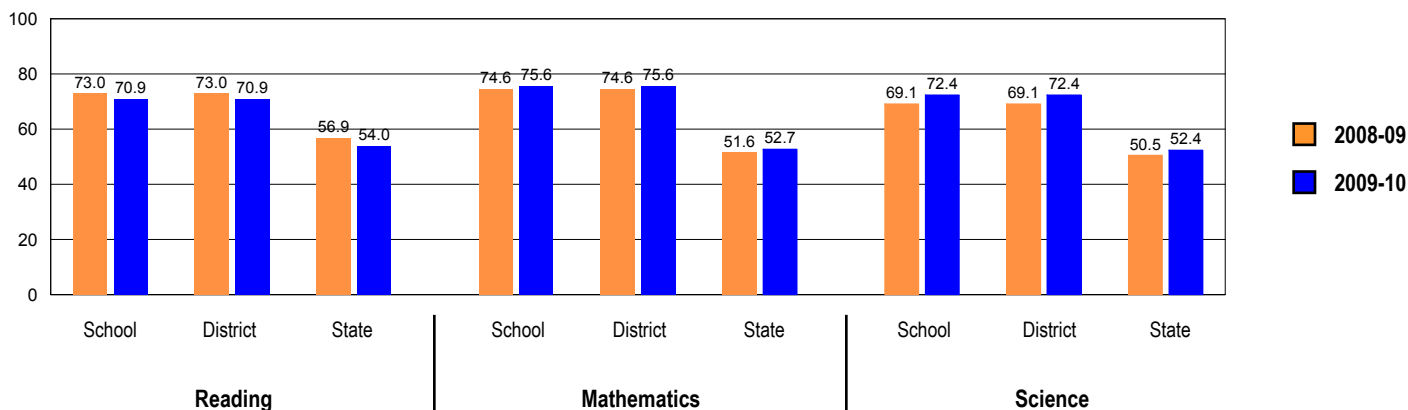


PSAE PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

PRAIRIE STATE ACHIEVEMENT EXAMINATION (PSAE)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 77.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 77.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. At least 91% attendance rate for non-high schools and at least 80% graduation rate for high schools.

* Includes only students enrolled as of 05/01/2009.

** Safe Harbor Targets of 77.5% or above are not printed.

*** Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

This is the final section of the school report card in which your school and district provide information below on areas of success and areas for planned improvement based on your school's improvement plan.

While our current achievement in reading for grade 11 shows 73.0% of all students in the Meets/Exceeds categories and 25.5% of student with disabilities in the Meets/Exceeds categories, the students in grade 11 and all subgroups will make AYP of at least 77.5% in 2010, 85% in 2011, and 92.5% in 2012 or they will meet Safe Harbor targets with 95% participation in 2010, 2011, and 2012.

While our current achievement in math for grade 11 shows 74.7% of all students in the Meets/Exceeds categories and 25.5% of student with disabilities in the Meets/Exceeds categories, the students in grade 11 and all subgroups will make AYP of at least 77.5% in 2010, 85% in 2011, and 92.5% in 2012 or they will meet Safe Harbor targets with 95% participation in 2010, 2011, and 2012.

The strategies to attain those goals include:

Select students and Special Education students will meet with a mentor or case manager to set reading and math goals for the PSAE.

All students including students with disabilities will participate in PSAE test preparation activities using KeyTrain, PSAE Coach, and online ACT materials.

Students will have the opportunity to participate in before-school PSAE tutoring.

Staff members will receive professional development and work in Professional Learning Communities to align curriculum and assessments to College Readiness Standards, Common Core Standards, and Advanced Placement programs.

Staff will receive training on the use a data and assessments for learning.

Staff will receive professional development on the use of reading strategies in all content areas, and select staff will receive professional development in the area of mathematics.

Staff will work in Professional Learning Communities to develop interventions for students who are not meeting targets.

Staff will monitor student attendance and intervene for students with low attendance.

Parents will receive information at Open House, via Messenger, and on the high school website regarding reading strategies and the math curriculum.

Parents will receive information about the PSAE: importance of the tests, key dates, and their student's accommodations. The information will be announced and also published on the website.

Outplaced students will be contacted by district student services staff regarding testing requirements and will be assessed at their serving school or at Batavia High School.
